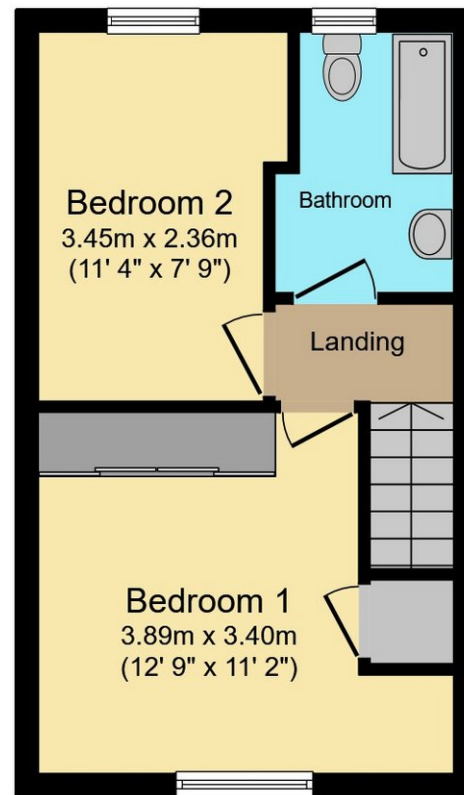








Ground Floor
